he lack of relevant work experience is a problem for many professionals starting in a new field or career in environmental management. The Environmental Management Internship Program gives certificate program candidates opportunities to apply their knowledge in professional industry or government agency settings. This experience can be very valuable in helping new environmental professionals find permanent positions.

Students who have completed at least 9 units of credit in a certificate program are eligible to apply to the program, as well as former students who have already completed their certificates. Participation in the internship offers chances to

- · network with employers and peers
- · gain practical experience for those just starting out in the environmental field
- make a career change
- update skills
- earn three units of academic credit toward fulfilling certificate program elective requirements

Interns spend a minimum of 150 documented hours in an environmental management setting that is directly applicable to their certificate study. Specific tasks assigned to interns vary, depending on the sponsor's needs and the area of environmental management in which the intern works. On-site supervision is provided by the sponsoring business or agency.

- site remediation
- environmental training
- laboratory research
- environmental administration
- regulatory support
- environmental consulting
